

Entry of Plea for Mandatory Court Appearances

Entry of Plea is only available for Beaver and Milford courts.
It is not available for the Minersville Court.

If your citation requires a mandatory court appearance an arraignment court hearing will be scheduled. If you would like to plead “guilty” or “no contest” before your court hearing you can go online to beaver.utah.gov or follow the QR code below and fill out an Entry of Plea form.



Deferred Traffic Prosecution

Deferred Traffic Prosecution is offered by the state of Utah for Utah residents over the age of 21.

You must apply within 21 days from the date of your citation.

Deferred Traffic Prosecution can keep points off of your driving record. If you qualify, you pay a fine like a normal ticket. Depending on your record, you might also have to take traffic school online and pay for that. Then if you maintain a clean record for 1 year your ticket will be dismissed off your record. If you would like to see if you qualify please go online to utcourts.gov or follow the QR code.



Traffic School/Plea in Abeyance

Plea in Abeyance is only available for Beaver and Milford courts.
It is not available for the Minersville Court.

If you desire to have your ticket dismissed to prevent points from being added to your driving record our court offers a Plea in Abeyance. A Plea in Abeyance requires you to complete an online traffic school and to you must maintain a clean driving record for 3 months. There is an addition \$25 dollars added to your court fine and you paid \$45 directly to the traffic school.

You do not qualify for a Plea in Abeyance if

- You have a CDL and/or
- You were charged with speed 100mph or over and/or
- You have had another ticket within the last year
